LAW OF GAMES/RULES	The competitions are conducted in accordance with the Law of Badminton World Federation (BWF).
SCORING SYSTEM	Elimination System All games will be played 1 x 30 points with no deuce, and the change ends when one side reaches 15 points.
DRAW & SCHEDULE	All draw schedule updates will be available to participants 3 days before tournament day. Please check at www.desapetalingbc.com or tournament software based on our tournament title.
ENTRY REQUIREMENT	Players are allowed a maximum of 2 events. All age calculations are based on year birth on IC/Passport (e.g. 2022-1998=24 years old).
TERMS & CONDITIONS	<ul style="list-style-type: none"> • Players must report 15 minutes before their scheduled time of play. The 10-minute default rule applies. • Event with insufficient entries may have its format altered, combined or may be cancelled and or reduce the prize should the entries be deemed insufficient of less than 16 entries. • In the event that the girls' entry is insufficient, the girls are allowed to play in the boys' event and will be given a 1-year of age advantage (e.g. Age 13 – Boys' Event 12). • All appeals/protests must be submitted in writing by the player(s) or team official(s) thirty (30) minutes after the match to the Honorary Referee. Such appeals/protests must be accompanied by a fee of RM200, which is REFUNDABLE only if the appeals/protests are unaided. Otherwise, it will be forfeited. The decision of the Jury appeal is final. • The Umpire's decision shall be final on all points of fact for which he/she is responsible. • The Referee's decision shall be final on all points of law, and there shall be no appeal. • The organiser reserves the right to change the match of any rule, entry requirement, conditions of competition, draw and schedule at the last moment under unavoidable circumstances without prior notice. • The organiser reserves the exclusive right to change, amend, delete or add to these Rules & Regulations without prior notice.

Important notice for all the participants: -

1. All draw schedule updates will be available to participants 3 days before tournament day. Please check at www.fourseasonsbc.com or tournament software based on our tournament title.
2. For all missing entry/partner change requests due to external factors or reasons, kindly help to notify the organiser via this link at www.fourseasonbc.com. There will be an admin charge of RM 30 for each change request after the closing date of 9 June 2023.
3. There will be no refunds after the submission of all the registrations after the closing date, as all details

have already been handed over to our technical officials for draw preparation. Participants will only get a replacement for their games and must notify our technical officials of a change of partner details and pay the administration fee during the tournament.

4. Only 2 shuttlecocks are provided during each game for 30 points system (Knock out basis) until final, and participants are allowed to bring their own shuttlecock if he/she would like to play with 3 - 5 shuttlecocks each game. The organiser allows such requests.
5. For draw schedule updates/game arrangements, kindly refer to the tournament software from time to time or check with our technical officials directly if there are any delays.
6. All protests or complaints can be directly submitted to our Referee or technical officials or fill up the protest form or online form at www.fourseasonsbc.com and refer our Referee for a decision. In this case, there will be a certain minimum fee required for the investigation process as this is part of our tournament rules and regulations.
7. All decisions are subject to the organiser's final approval, and technical officials are the independent party to ensure all games are arranged in a professional manner where our objective for this event is to enjoy a fun time and practice a healthy lifestyle within our community.
8. All winners' results will be available on our tournament software and a copy of the winners' results will be sent to the respective State Badminton Association for their reference.
