#### **NOTICE ON ENHANCED MOVEMENT CONTROL ORDER IN SELANGOR AND KUALA LUMPUR**

Due to high COVID-19 infectivity trends in Selangor and Kuala Lumpur, the National Security Council (MKN) based on Ministry of Health guidance, has decided to implement an Enhanced MCO in Selangor and several localities in Kuala Lumpur from 3 to 16 July 2021.

In line with this decision, the Ministry of Transport informs the following updates to agencies and matters under its purview:

#### **JPJ, APAD, PUSPAKOM, and JLM COUNTER SERVICES**

- In a statement on 30 June, MOT had announced the re-opening of counter services under Phase One of the MCO under the National Recovery Plan for transactions/services that are unavailable online.
- However, during the EMCO period in Selangor and Kuala Lumpur, all counter services operated by the above agencies will remain closed except for those in Kuala Lumpur that are not within the EMCO localities. Kindly refer to the respective agencies for further information.

#### **TRAVEL APPROVAL LETTERS FROM SMILE**

- Approval letters obtained from MOT's SMILE system are still valid for travel during this EMCO. Applicants do not need to download a new letter if they have been granted one previously.

#### **PRIVATE VEHICLE USE**

- Only one person from each household is allowed to use their own vehicle (of any seating capacity) to obtain necessities within a 10-kilometre radius of their residence. Police permission is required for additional persons to be allowed.

- Use of private vehicles for inter-state and inter-district travel to receive vaccinations at vaccination centres are allowed with MySejahtera appointments and other relevant information as travel permission. A maximum of two persons (including the patient) in a private vehicle is allowed to travel for healthcare, medical, or vaccination purposes.

### **TAXI AND E-HAILING SERVICES**

- Only two persons including the driver are allowed in a taxi or e-hailing vehicle.

### **PUBLIC TRANSPORT AND LOGISTICS INDUSTRIES**

- Trains, LRT, MRT, ERL, Monorel, buses, taxis, ferries, and e-hailing services are allowed to operate at 50% passenger capacity.
- Airports and ports may continue to operate as normal. Commercial transportation and activities related to the supply chain of essential services via land, air, and sea are allowed to operate during the EMCO, including food and parcel delivery services.
- Port services and related enterprises including shipyards, lighterage, cargo and commodity handling, pilotage, and loading/unloading within port areas are permitted. Loading and unloading activities outside of port areas under EMCO are permitted only for approved essential services.
- Number of passengers allowed on commercial and logistics vehicles are subject to their respective vehicle registrations.
